## 中小企業最佳拍檔獎 Best SME's Partner Award

### 申請須知

### Application Guidelines



香港中小型企業向來是香港工商業的重要支柱之一，佔香港所有註冊企業的98%，在私營企業中僱用了超過60%的就業人口，其重要性不言而喻。

SMEs have always been one of the pillars of Hong Kong's economy. Accounting for 98% of all registered companies in Hong Kong and employing more than 60% of the working population in the private sector, their importance is self-evident.

為推動香港中小企的持續發展，本會於2006年創辦「最佳中小企業獎」及「中小企業最佳拍檔獎」，藉此公開嘉許及表揚獲獎中小企業的企業精神及曾經給予中小企業大力支持的拍檔企業。

To promote sustainable development of Hong Kong's SMEs, the Chamber established the "Best SME's Award" and "Best SME's Partner Award" in 2006 to publicly recognize and commend the entrepreneurial spirit of winning SMEs and partner organizations that have provided great support to local SMEs.

同時，為鼓勵青年創意創業精神及表揚其獨創營銷意念，本會於2014年得到「鵬程慈善基金」的支持，創辦了「鵬程中小企青年創意創業獎」，以肯定及加強他們的創意理念及持續發展。

Furthermore, to encourage young creative entrepreneurship and praise their original marketing ideas, with the supported of the "Bright Future Charitable Foundation", the Chamber in 2014 established the "Bright Future SME's Youth Creative Entrepreneurship Award", thereby affirming and strengthening their innovation drive and continuous development.

## 宗旨 Purposes

- 表揚參選機構 / 企業對香港中小企業的支持及配合  
Recognize the support and cooperation that participating organizations/companies have provided to SMEs operating in Hong Kong;
- 增強社會各界對獲獎機構 / 企業的認識  
Enhance community awareness and understanding of the award-winning organizations/companies;
- 持續及增強香港中小企業之競爭力  
Enhance and sustain the competitiveness of Hong Kong's SMEs;
- 鼓勵參選機構 / 企業繼續支持香港中小企業的業務營運和發展  
Encourage the participating organizations/companies to continue support the business operation and development of Hong Kong's SMEs.

## 參選資格 Eligibility

1. 參選機構 / 企業必須為香港註冊公司，並且以香港為主要的營運基地。  
Participating organizations/companies ('candidates') must be registered in Hong Kong, and using Hong Kong as their main operating base.
2. 參選機構 / 企業在過去對香港中小型企業的業務營運和發展，曾經給予支持和配合，並得到顯著的成效和貢獻。  
Candidates have worked closely with Hong Kong's SMEs in the past, providing support to their business operations and development, achieving remarkable results and making major contributions.
3. 參選機構 / 企業必須在香港註冊超過三年或以上。  
Candidates must have registered in Hong Kong for three years or more.

## 評審標準 Judging Criteria

參照以下五個標準作出評分：

Scores are assigned according to participating organizations'/companies' performance/achievement/ contribution in the following five areas:

- a. 機構/企業所提供之產品或服務對中小型企業的重要性？  
How important are the products/services offered by the organization/enterprise to SMEs?
- b. 機構/企業設有甚麼機制，能使之不斷地為中小企業客戶提供合適的產品和服務？  
What mechanism does the organization/enterprise have established to enable it to continue provide SME customers with suitable products and services?
- c. 機構/企業為中小企業所提供之產品或服務，為中小型企業的發展作出怎樣的具體貢獻？  
What specific contribution the organization/enterprise has provided to SMEs for their development?
- d. 機構/企業為了服務中小企業客戶，營造了一個怎樣的機構文化，及如何重視中小企業客戶？  
What kind of organizational culture the organization/enterprise has nurtured to serve SME customers and how does it treasure its SME customers?
- e. 機構/企業設有甚麼合作和溝通機制，維持與中小企業客戶的和諧關係及進一步促進彼此之間的瞭解？  
What cooperation and communication mechanism has the institution/enterprise installed to maintain a harmonious relationship with SME customers and further promote mutual understanding?

參選機構/企業可根據以上五個標準，提供公司之企業簡介(如產品類別或服務對象、發展歷史及內地業務等)和值得甄選及評審委員會揀選的原因，撰寫報告並以簡報(PowerPoint)形式遞交。評審在遞交的文件中，綜合考慮參選機構/企業提供的資料決定獲獎名單。

With reference to the above five criteria, participating organizations/companies may furnish a corporate profile (covering areas such as product type, service targets, development history and their Mainland business, etc.), highlight reasons why the judging panel should elect them, and submit a report, supplemented with PowerPoint presentation files as appropriate. All submitted documentation would be thoroughly examined in confidence to arrive at a final winner list.

## 參選得益及回報 Benefits and Rewards

- 彰顯獲獎機構/企業給予中小企業的支持及貢獻  
Highlight the support and contributions that the award-winning institutions/enterprises have provided to SMEs;
- 提升獲獎機構/企業的形象  
Enhance the image of the award-winning institutions/companies;
- 提升獲獎機構/企業在其所屬行業的知名度及專業認受性  
Raise the level of recognition and professional acceptance of the award-winning institutions/enterprises in their respective industries; and
- 肯定獲獎機構/企業在社會的成就  
Acknowledge the achievements of the award-winning institutions/enterprises in society.

此外，大會更會透過傳媒對獲獎機構 / 企業作廣泛報導，包括在香港與內地有關中小企業的展覽會中宣傳，務求令社會各界得知獲獎機構 / 企業是香港中小型企業的典範，獲獎機構 / 企業除獲邀出席主辦單位香港中小型企業總商會所舉辦的頒獎典禮暨晚宴外，在提升知名度的同時，日後可在其宣傳資料及廣告內，使用【中小企業最佳拍檔獎】的標誌，於進行市場推廣時，宣傳獲獎的卓越成就。

The Chamber will also widely publicize the organizations'/companies' award winning through the media, including publicity in local and Mainland SME-related trade fairs, to enable the community and trades to be well aware of the award-winning institutions/companies as good role models of Hong Kong's SMEs. In addition to being invited to attend the Award Ceremony and Dinner hosted by the Hong Kong General Chamber of Small and Medium Business, winners can incorporate the Best SME Partner Award logo in their future promotional materials and advertisements, leveraging on the honor and glory they have gained in recognition of their achievements.

Winners of the "Best SME's Partner Award" will be conferred an award logo of the year that they can permanently replicate on their organizations' business cards, publications and all publicity materials.

## 獎項 Awards

There are two partnership awards, namely, "Best SME's Partner Award" and "Best SME's Partner Gold Award".

1. 【中小企業最佳拍檔獎】頒授予對香港中小型企業的業務營運和發展給予支持和配合的機構/企業，並得到顯著的成效和貢獻。

The "Best SME's Partner Award" is for recognizing organizations/companies that support and coordinate business operations and development of Hong Kong SMEs, making remarkable contributions and achieving significant results.

2. 【中小企業最佳拍檔金獎】頒授予已連續十年或以上成功獲獎之企業。

The "Best SME's Partner Gold Award" is presented to organizations/companies that have successfully won awards for 10 consecutive years or more.

獲獎名額由評審團視乎各參選企業的背景及資格來決定。各獲獎企業均獲頒發獎座及錦旗。

The number of winners will be determined by the judging panel depending on the background and qualifications of the candidates. Award-winning organizations will each be presented a trophy and a banner.
